- Multilateral Negotiation – Market Key Mitigation Financing Instrument
 - Development and Linking ETS
 - Continuation of CDM
 - Evolution of CDM evolution of other instruments

UK Support to Practical Implementation

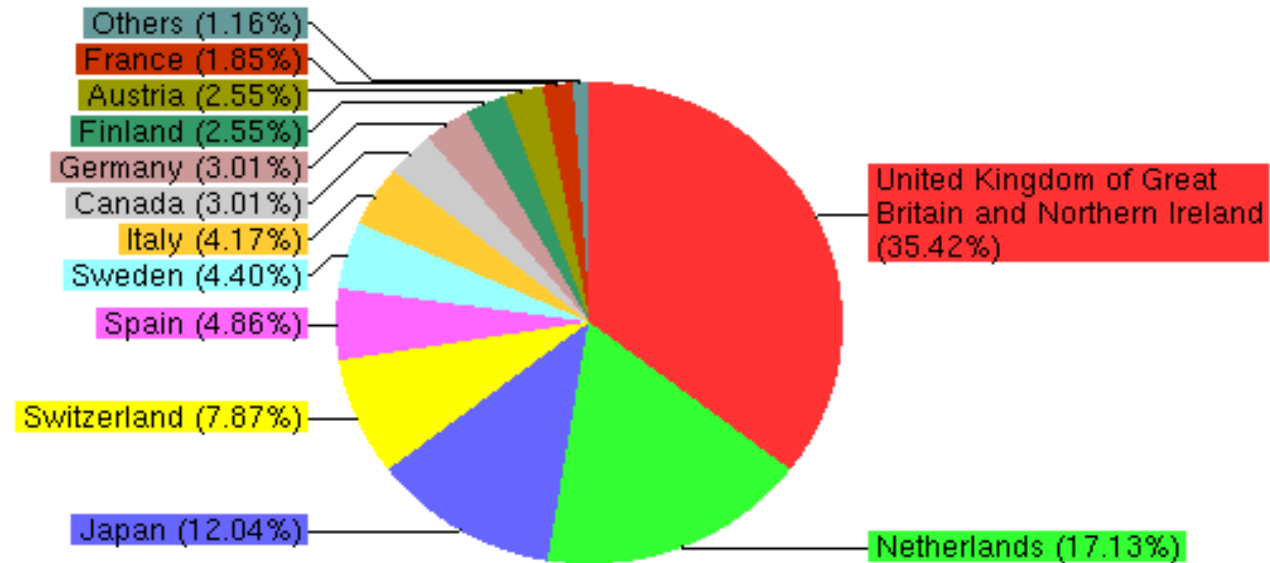


- Greta – 17 Registry Systems based on common software
 - EU ETS Standards and UN ETS Standards
 - Versioned Systems
 - Implementation timetable dictated by linking and testing requirements
 - Cooperate closely Commission and UNFCCC

Kyoto Protocol



- Article 17 International Emissions Trading - Transfer and Acquisition of Kyoto Units between Annex I Parties
- Assigned Amount needed to Meet Kyoto Emissions
- National Inventory and National Registry Systems
- Compliance at end of KP period – Retirement to meet emissions 2008-2012

EU Requirements



- Monitoring Mechanism Decision
 - Kyoto Implementation – National Systems
 - Early Annual Retirement “withdrawal of assigned amount” each inventory
- EU ETS Directive
 - transfer of allowances to be accompanied by “corresponding adjustment of assigned amount”
 - EU ETS Registries
- Registry Regulation
 - EUA = converted AAU
 - Early retirement to cover EU ETS Emissions

Implications – UN Eligibility and Linking



- Legal and Practical Requirements separate concepts
 - Forwarding of CERS on linking
 - Issuance of AAU and EUA on linking
 - Transfer and Acquisition of EUA on eligibility

Establishing Eligibility

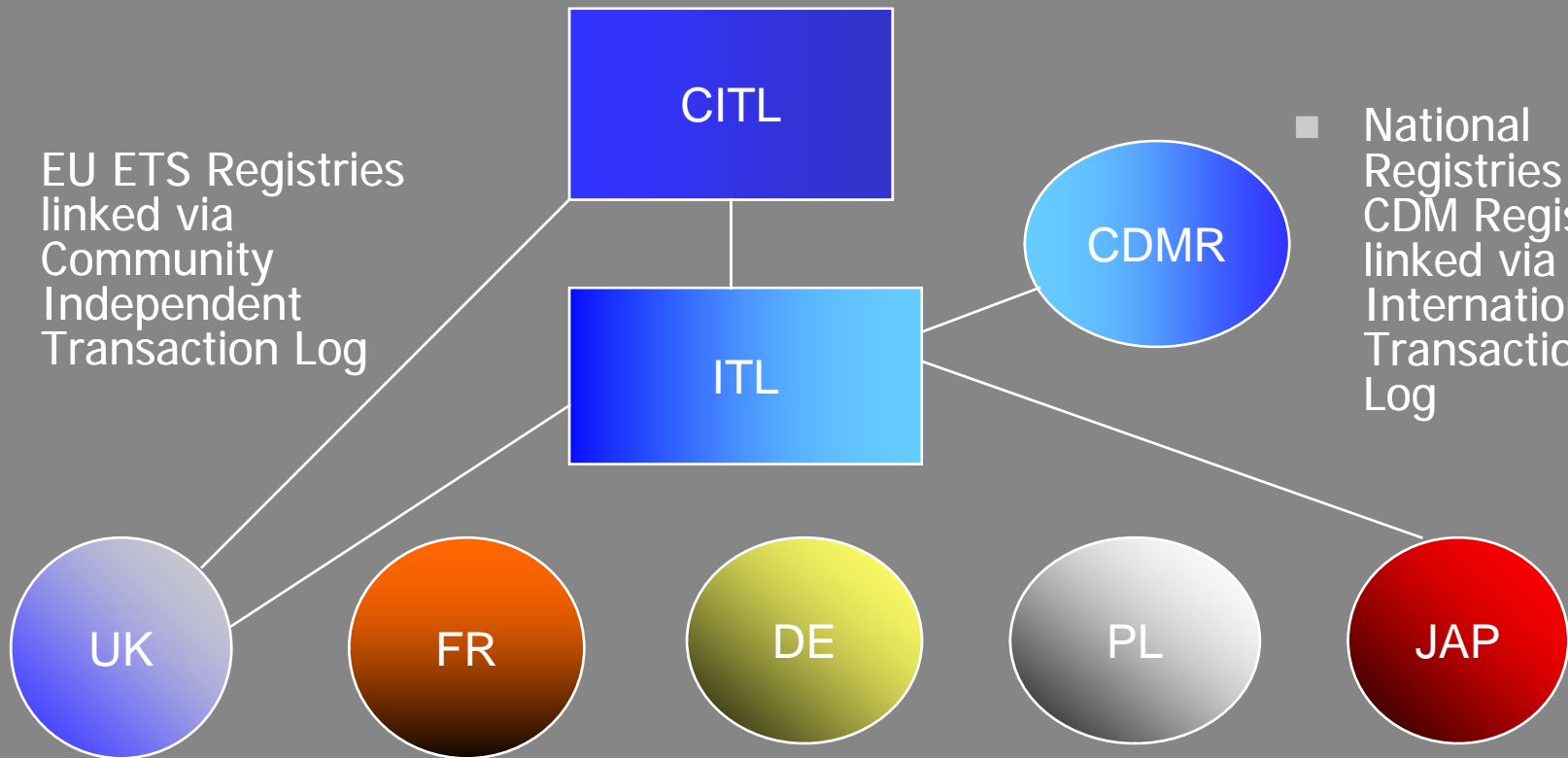


- Initial Reports – Establishing Assigned Amount
- Calculations + National Inventory System + National Registry Systems
- Review Process 16th Month Automatic Eligibility in absence of eligibility
- UK submitted December 2006
- UK Report on All Elements
- Review Team Visit – Mid March
- Registry Compliance Tests July
- Final Report end July

- EU ETS Registries linked via Community Independent Transaction Log



- National Registries and CDM Registry linked via the International Transaction Log

- EU National Registries and EU ETS Registries combined
- EU and UN Checks on EUAs
